

**PUBLIC NOTICE**  
**LEFLORE COUNTY SOLID WASTE DEPARTMENT**

In order that the Leflore County Solid Waste Department may better serve the needs of the citizens of Leflore County and comply with the state and federal guidelines, the following procedures and guidelines need to be followed. If you have recently moved into Leflore County, please call the Leflore County Courthouse, 662-455-7907, for additional information.

**RESIDENTIAL OR HOUSEHOLD GARBAGE**

1. EVERY RESIDENCE IN LEFLORE COUNTY, OUTSIDE THE CITY LIMITS OF GREENWOOD AND ITTABENA WILL BE BILLED FOR GARBAGE PICK UP.
2. WEEKLY PICK UP IS AVAILABLE FOR A FEE OF \$9.50 OR AS DETERMINED BY THE BOARD OF SUPERVISORS.
3. GARBAGE CANS MUST MEET SPECIFICATION WHEELS AND LOCK DOWN TOP NO LARGER THAN 95 GALLONS CAPACITY. GARBAGE WILL NOT BE COLLECTED IF CANS DO NOT MEET SPECIFICATIONS. 95 GALLON CONTAINERS ARE AVAILABLE FROM SOLID WASTE DEPARTMENT FOR A RENTAL FEE OF \$25.00. THIS CAN MUST MATCH AND THIS CAN IS FOR YOUR USE AS LONG AS YOU CONTINUE TO LIVE IN THE PICK UP AREA.
4. IF YOU MOVE, PLEASE LET US KNOW. IF YOU MOVE OUT OF LEFLORE COUNTY AND HAVE A LEFLORE COUNTY TOTE, PLEASE RETURN IT TO THE SOLID WASTE DEPARTMENT. FAILURE TO DO SO MAY RESULT IN LEGAL ACTION.

**RUBBISH**

**RUBBISH INCLUDES**

Small Limbs-----small limbs must be cut to 6 feet lengths or smaller

Yard Clippings----- (leaves, grass, pine needles and pine cones) must bagged

**FURNITURE BEDDING**

1. RUBBISH PICK UP IS WEEKLY IN SUBDIVISIONS AND AS NEEDED, OR **CALLED** IN FOR RURAL AREA.

2. RUBBISH MUST BE PLACED NEXT TO COUNTY ROAD OR STREETS, AWAY FROM POWER LINES, CABLE LINES AND TREES. DO NOT PLACE RUBBISH IN COUNTY DITCHES OR DRAINS.
3. RUBBISH WILL BE COLLECTED IN REASONABLE AMOUNTS (NO MORE THAN A PICK UP BED FULL).

THE FOLLOWING ITEMS WILL NOT BE PICKED UP:

1. ROOFING
2. DEBRIS FROM DEMOLITION OR REMODELING PROJECTS
3. WHITE GOOD (refrigerators, deep freezers, air conditioners) MAY BE TAKEN TO THE LANDFILL ON HWY 49 AND PLACED IN DESIGNATED AREAS. THERE IS NO CHARGE FOR THIS SERVICE.
4. HAZARDOUS MATERIAL (batteries, paints, solvents, oils, antifreeze, and other hazardous materials or liquids).
5. RUBBISH AND TREES LEFT BY PRIVATE CONTRACTORS (lawn and tree services, loggers, pulpwood operators, roofers, builders, lot cleaners and realty companies).
6. TIRES

NO ILLEGAL ROAD SIDE DUMPING

ILLEGAL DUMPING IS AGAINST THE LAW AND VIOLATORS WILL BE PROSECUTED TO THE FULLEST EXTENT OF THE LAW.

NO RUBBISH OR GARBAGE WILL BE PICKED UP AT UNOCCUPIED HOUSES OR EMPTY LOTS.

If you are a landlord, please make sure your renter is paying their garbage bill. If they are not paying, you are responsible for the billed amount. Call 662-455-7907 if you have questions concerning this matter.

**THE LEFLORE COUNTY SOLID WASTE WILL NOT PICK UP  
TIRES**

**INDIVIDUALS MAY TAKE TIRES, BETWEEN THE HOURS OF  
8:00AM AND 3:30 PM, MONDAY-FRIDAY, TO THE FOLLOWING  
LOCATIONS:**

- 1. LEFLORE COUNTY UNIT SYSTEM BARN ON HIGHWAY 7**
- 2. THE GREENWOOD CITY BARN ON PARKWAY ST.**
- 3. THE ITTABENA CITY BARN IN ITTABENA BEHIND THE  
POLICE AND FIRE DEPT.**

**THERE IS NO CHARGE FOR THIS SERVICE. BUSINESSES  
THAT SELL OR REPAIR TIRES ARE EXCLUDED FROM THIS  
SERVICE. PLEASE BE SURE TO PUT TIRES IN TRAILER NOT ON  
THE GROUND.**

**OWNERS, REALTORS, LOT CLEANERS AND CONTRACTORS**

THE PROBLEM OF GARBAGE, REMODELING MATERIALS AND LAWN CLEANING DEBRIS BEING PUT IN FRONT OF VACANT HOUSES NEEDS TO BE ADDRESSED

THE MAJORITY OF THESE HOUSES ARE THOSE BEING RENOVATED FOR RESALE. THESE HOUSES ARE NOT IN THE BILLING SYSTEM AFTER SELLER AND/OR RENTER MOVES OUT.

LEFLORE COUNTY SOLID WASTE WILL NOT PICK UP ANY GARBAGE OR RUBBISH AT UNOCCUPIED HOUSES NOT IN THE BILLING SYSTEM.

FROM NOW, ON YOU MUST GET A ROLL OFF BIN OR PROVIDE YOUR OWN HAULING TO THE LAND FILL.

THESE COMPANIES LISTED BELOW WILL FURNISH YOU WITH THE PROPER EQUIPMENT TO HOLD ALL THE DEBRIS GENERATED WHEN REMODELING OR CLEANING LOTS. PLEASE MAKE YOUR ARRANGMENTS BEFORE BEGINNING WORK.

THE LEFLORE COUNTY SOLID WASTE DEPT. PICKS UP GARBAGE IN THIS AREA. SINCE YOU HAVE RECENTLY MOVED INTO THIS AREA, YOU MIGHT NEED INFORMATION THAT WOULD EXPLAIN WHAT YOU NEED TO DO FOR GARBAGE SERVICE.

YOU MAY CALL 662-455-7907 AND TALK WITH GABRIEL BRISCO OR 662-299-4344 AND TALK WITH JIMMY GIBSON. THE INFORMATION NEEDED IS YOUR MOVE IN DATE, 911 ADDRESS, PHONE NUMBER AND YOUR ADDRESS IF DIFFERENT FROM YOUR 911 ADDRESS. YOU CAN ALSO COME TO THE TAX COLLECTOR'S OFFICE IN THE LEFLORE COUNTY COURTHOUSE AND GIVE THE ABOVE INFORMATION. THE MONTHLY GARBAGE FOR PICK UP SERVICE ONE TIME A WEEK IS \$ 9.50 FOR RESIDENTIAL AND \$10.00 FOR COMMERCIAL. YOU WILL ALSO NEED TO GET A GARBAGE CAN THAT MEETS SPECIFICATIONS. THAT PROCESS IS EXPLAINED IN THE ENCLOSED SHEETS.

ENCLOSED ARE GUIDELINES THAT WILL HELP YOU UNDERSTAND WHAT WILL BE PICKED UP AND WHAT WILL NOT BE PICKED UP BY THE SOLID WASTE DEPT.
